BRIEF RECORD OF PROCEEDINGS**

**The Council met in the Council Hall, Jammu at 11: 00 A.M.
(Hon'ble Chairman Haji Anayat Ali in the Chair)**

As soon as House assembled for today's business Members from the Opposition were on their feet, Members from NC raised issue of civilian killing of Khudwani, Kulgam yesterday, Members from Congress were demanding apology from a member namely Shri G.L Raina for using un-parliamentary words against their central leader. Besides this Shri Naresh Kumar Gupta raised point regarding the shortage of drinking water in Hallad area. Shri Javid Ahmad Mirchal raised the issue that no coverage was given to the issue of tunnel construction at Sadna Top. On this Chair directed to Director Information to look into the matter and give proper coverage to Upper House proceedings. Shri Ghulam Nabi Lone, Hon'ble Minister for Agriculture made the statement on yesterday's killing of a youth at Khudwani Kulgam and informed the House that District Magistrate, Kulgam has ordered an inquiry into the matter, for which Shri Nazir Ahmad Khwaza, Additional DDC, Kulgam has been appointed as Inquiry Officer. Not satisfied with the statement of Hon'ble Minister Members came into the well. Chair directed to Government to conduct inquiry on fast track.
