POINT OF INFORMATION

Shri Surinder Mohan Ambardar, Hon'ble Member, urged that debate/discussion should be held on privileges and protocol of the MLC's in the House. All Member supported him.

Shri Ramesh Arora, Hon'ble Member, raised the issue of killing of army personnel at Chakanda-Bagh . Which is our area and stated that Government should condemn this.

Shri Yasir Reshi, Hon'ble Member, raised issue regarding encroachment of Kahchaire land at Humhama by some influential persons requested that report of the Committee be tabled. He also requested that a House Committee be constituted to look into it.

Shri Firdous Ahmad Tak, Hon'ble Member, requested the Chair to call back the Members from Opposition, who did not attended the House today in protest of yesterday's incident on the issue raised by Shri Sajjad Ahmad Kitchloo which is genuine and requested the Chair to allow Half An Hour Discussion on Power projects of Kishtwar .
