**POINT OF INFORMATION**

**Shri. Vibod Gupta, Hon'ble Member** demanded full details of Daily-Wagers/Casual Labours engaged in District Rajouri.

**Shri. G.L. Raina, Hon'ble Member** raised an issue regarding JDA land grabbing by some land mafia at K. B. Nagar Bantalab.

**Shri. Naresh Kumar Gupta, Hon'ble Member** demanded inclusion of Padder, Balasia Badarwa, Pugal, Sarai Sara Doda, Bari Kathua and Kishtiwari areas in Pahari speaking list as these areas are missing in the Booklet published by Social Welfare Department.

**Shri. Ramesh Arora, Hon'ble Member** demanded removal of encroachment at River Tawi as announced by Hon'ble Chief Minister in a public rally as well as in review meeting.

**S. Charanjeet Singh, Hon'ble Member** demanded discussion on his Starrer C.Q. 467 which could not be taken up today.

On this **Chair** directed the **Hon'ble Member** to submit the application in this regard as per Rules & Procedure & conduct of Business and the same will be looked into.

**12:05 Hrs.** **CALLING ATTENTION**

(I) **Shri Vikram Randhawa, Hon'ble Member** called the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to encroachment of Government land adjoining River Tawi aftermath 2014 floods and the steps taken by the Government in this behalf.

**Hon'ble Deputy Chief Minister, Dr. Nirmal Singh, I/C Housing & Urban Development replied the points raised by the Hon'ble Member.**

**(II) Mr. Zafar Iqbal Manhas, Hon'ble Member** called the attention of the government towards the manipulative erection of unauthorized and illegal restaurants, bakery shops, tea stalls, timber depots etc across NHW and adjoining Circular road near Grid station at Sanat Nagar Bye pass resulting in massive traffic hazards and dumping of garbage and waste food giving way to harmful assembly of stray dogs, hence the instant purpose oriented action taken in this regard.

**LEGISLATIVE BUSINESS**

**PRIVATE MEMBERS' BILLS FOR INTRODUCTION**

**(I) Mr. Qaiser Jamsheed Lone, Hon'ble Member** moved for leave to introduce :-

**“A Bill to amend the Jammu and Kashmir Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1998” [L.C Private Members' Bill No. 13 of 2018].**

**Mr. Showkat Hussain Ganai , Hon'ble Member seconded the Bill.**

**Mr. Sajad Ganai Lone, Hon'ble Minister for Social Welfare opposed the Bill.**

**Mr. Sajad Ganai Lone, Hon'ble Minister for Social Welfare** replied the points raised by the Hon'ble Member and requested the Member to withdraw the Bill. The Bill was withdrawn by the Hon'ble Member with the permission of the House. Bill stood **Withdrawn**.

**(II) Shri Naresh Kumar Gupta, Hon'ble Member** moved for leave to introduce :-

**“A Bill to amend the Jammu and Kashmir Electricity Act, 2010.”[L.C Private Members' Bill No. 8 of 2018].**

**Mr. Showkat Hussain Ganai , Hon'ble Member seconded the Bill.**

**Mr. Ab. Haq Khan, Hon'ble Minister for RDD, for opposed the Bill.**

**Mr. G. N. Monga, Firdous Ahmad Tak & Shri. Ramesh Arora Hon'ble Members also spoke on the Bill.**

**Mr. Ab. Haq Khan, Hon'ble Minister for RDD** replied the points raised by the Hon'ble Members and requested the Member to withdraw the Bill.

The Bill was withdrawn by the Hon'ble Member with the permission of the House.

Bill stood **Withdrawn**.

**(III) on behalf of Dr. Shenaz Ganai, Hon'ble Member, Mr. Qaiser Jamsheed Lone, Hon'ble Member** moved for leave to introduce:-

**"A Bill to enforce, implement and promote complete prohibition of liquor and intoxicants in the territory of the State of Jammu and Kashmir and for matters connected therewith or incidental thereto."**[L.C Private Members' Bill No. 4 of 2018].

**Shri. Naresh Kumar Gupta , Hon'ble Member seconded the Bill.**

**Shri. Ajay Nanda , Hon'ble Minister of State for Finance opposed the Bill.**

**Shri. Ajay Nanda , Hon'ble Minister of State for Finance** opposed the Bill and replied the points raised by the Hon'ble raised and requested the **Hon'ble Member** to withdraw the Bill. Not satisfied with the reply Hon'ble Member pressed for voting. The Bill was defeated by Voice Vote.

**(IV)On Behalf of Dr. Shenaz Ganai, Mr. Qaiser Jamsheed Lone, Hon'ble Member & Mr. Ghulam Nabi Monga Hon'ble Members** moved for leave to introduce:-

**"A Bill to amend the Jammu and Kashmir Panchayati Raj Act, 1989."**[L.C Private Members' Bill No. 3 of 2018].

**Shri. Naresh Kumar Gupta , Hon'ble Member seconded the Bill.**

**The discussion on Bill No. 3 of 2018** remained inconclusive and Chair directed the leftover Bills including the Bill under discussion will be taken up on the scheduled date fixed for Private Members Bill as per the Calendar.
