AjatShatru Singh, Hon'ble Member also raised a point that Resolution regarding declaring holiday on birth anniversary of Maharaja Hari Singh was passed in the House during last Budget Session but no action has been taken by the Government on the Resolution and staged walkout . Hon'ble Chairman asked the members to take their seats so that Question Hour is run smoothly but Members continued to protest and came into the well.
