The Council met in the Council Hall, Jammu at 11: 00 A.M. (Hon'ble Chairman, Haji Anayat Ali in the Chair)

11:00 Hrs.

As soon as the House assembled for today's Business, all Hon'ble Members cutting across party lines stood up from their seats and lodged a strong protest against the Press and Electronic Media for poor coverage of proceedings despite passing the directions by the Chair, from time to time. The chair asked Mr. Sajjad Kichloo, Hon'ble Member to speak and tried to pacify the Hon'ble Members but they continued protest and staged walk-out. Chair adjourned the House for ten-minutes.

Point Of Information

<u>Mr. Qaiser Jamsheed Lone, Hon'ble Member</u> once again demanded reply from Government regarding the death of six-year old girl of Wadoora Sopore by stray dogs biting yesterday.

While responding Mr. Javid Mustufa Mir, Hon'ble Minister for Relief and Rehabilitation made a statement in this regard and stated that since it is a serious and state wide issue and concern of all as such we should formulate a policy to meet the challenge and also said that the issue will be taken up with the concern for providing relief.

Mr. G. N. Monga, Hon'ble Member raised an issue regarding allotment of Vehicles to Legislators and its depreciation cost after retirement as referred in Government order and said the same is not being implemented and demanded statement from Government in this regard.

Mr. Ab. Rehman Veeri, Hon'ble Minister for Parliamentary Affairs in response to this said that the issue will be taken up with D.G. Police vis-à-vis Home Department.

<u>Mr. Sofi Yousuf, Hon'ble Member</u> raised an issue of yesterday firing incident at SMHS Srinagar in which two Police personnel died and demanded enquiry and statement by the Government on the same.

<u>Mr. Firdous Tak, Hon'ble Member</u> condoled the death of two-Police Jawans in yesterday's incident at SMHS hospital Srinagar and demanded that the House should condole their sacrifice.

<u>Shri. Ramesh Arora, Hon'ble Member</u> demanded statement regarding the killing of two Police personnel in yesterdays firing in Srinagar and steps taken by the Government on the Militant who fled.

Shri. Surinder Mohan Ambardar, Hon'ble Member demanded that a cricket match be played between Lower House and Upper House.
