**OBITUARY REFERENCE**

**11:00 Hrs.** As soon as House assembled for today's business Members from the Opposition raised the issue of attending the party meeting by the Hon'ble Chairman at the residence of Hon'ble Chief Minister. The Hon'ble Chairman asked all the Hon'ble Members to take their seats and read the obituary on the sad demise of Mr. Akhter Nizami, Ex MLA, two minutes silence were observed by Hon'ble Members and pay tribute to the departed soul. On this Hon'ble Chairman stated that he has give clarification through press. He further stated that he went there to thank Hon'ble Chief Minister for construction of Zojila Tunnel and not for dinner but all opposition Members came into the Well. Shri Javiad Ahmad Mirchal raised the incident which occurred at the Sadna Top Tangdar, due to the snow avalanche in which some precious lives were lost and wanted to know about the status of Sadna Top Tunnel.

On this Shri Naem Akhter Indrabi Hon'ble Minister for R&B state that Government is very much concerned about the recent incident and is giving top priority for construction of tunnel at Sadana Top at Tangdar which remains cut off for six months. He also informed that when Union Defense Minister visited the valley, Hon'ble Chief minister raised, the issue regarding construction of various tunnels including Sadna Tunnel .

Hon'ble Chairman welcomed Mr. Tasaduq Hussain Mufti, Minister for Tourism in the House and allowed the Question Hour.
