2. CALLING ATTENTION

- i. **Dr. Shenaz Ganai, Hon'ble Member** to call the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to non-availability of Degree College at Tehsil Mandi, District Poonch and steps taken by the Government in this behalf.
- ii. **Shri Ramesh Arora, Hon'ble Member** to call the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to exclusion of the village Chhangam Sarthal, Tehsil and District Kishtwar in providing drinking water facility from the scheme sanctioned to Fagwar and Drab of the same Panchayat from Nala Galigad (Khalnokhs) Water Scheme with the result the people are subjected to lot of hardships and the steps taken in this behalf to redress the grievances of the people of this far flung area.

3. PRIVATE MEMBERS' RESOLUTIONS

- i. **Mr. Saif-ud-Din Bhat, Hon'ble Member** to move that:-
"This House resolves that more emphasis be placed on development works in the villages being backbone of the economy of the State to ensure equal development of rural areas and to change the outlook of the villages as per changing scenario of the world".
