The Council met in the Council Hall Srinagar at 11.00 Hrs.

As soon as the House assembled for today's business, The Hon'ble Members from Opposition raised the issue on entry of Media Persons. The Hon'ble Chairman pacified the Members by saying that no such direction has gone from this House. The Media Persons have already issued passes through Information Department and the Media Persons are free to cover the Proceedings of The House. The Members from the Opposition were not satisfied with the statement of Hon'ble Chairman and continued the disturbance in the House. In the meanwhile the **Syed. Naeem Akhter Andrabi, Leader of the House (Minister for R&B)** informed the House that there is no restrictions on Media and requested the Members of the Opposition Benches to take their respective seats and participate in the discussion on Resolution, but the Hon'ble Members from the Opposition continued their protest by raising slogans against the restrictions on entry of Media persons in the House.

RESOLUTION

That this House resolves that the Government of Jammu and Kashmir may give consent to the adoption of the GST regime by application of relevant amendments made to the Constitution of India in a modified manner to safeguard the existing special constitutional position of J&K in the Union of India and the legislative powers under the Constitution of Jammu and Kashmir.

The Resolution was seconded by Mr. Vikramaditya Singh & Surinder Choudhary, Hon'ble Members.

Members from opposition moved towards well and created ruckus in the House.

As soon as the House Reassembled the Hon'ble Members from the Opposition were again resorted protesting for revoking restrictions on Media Persons, and tried to move towards the well and were shouting slogans and created ruckus in the House. There were confrontation and verbal dual between Members from Opposition and Treasury Bench.

12:35 Hrs House again Re-Assembled.

As soon as House Reassembled Hon'ble Chairman condemned the incident, mean while Members from opposition were demanding apology from the Chair and continued their protest and were shouting sloganeering against the Government.
