**Point Of Information.**

**Mr. G. N. Monga, Hon'ble Member** raised a point regarding Non-Seriousness of Government/ Administration towards this House and Stated that Government is not taking this House seriously as the Government Vehicles & Escort Vehicles were not provided in time to the MLC,s. He further stated that the non-serious approach of the government can be gauged by the fact that though the Home Department has directed the DG/ADG to provide Pilot/ Escort Vehicles to the Hon'ble Chairman as has been provided to Hon'ble Speaker, but the concerned agency has not complied the order till date and requested the Chair to direct the Government to take this House Serious.

**Haji. Anayat Ali, Hon'ble Chairman** directed the Government to redress the grievances/ demands of the Hon'ble Members regarding Escort/ Vehicles and Residential Accommodation.

**Starred C.Q.Nos. 331, 81, 539, 493, 304 & 600 were orally answered.**

In response to **Starred C.Q.No. 331** asked by **Shri. Showkat Hussain Ganie** regarding construction work on Nallah Tongri Shopian, On behalf of **Minister for Agriculture, Mr. Abdul Haq Khan, Minister for RDD** assured the House that case will be examined and funds will be utilized for the same work.

In response to **Starred C.Q.No. 539** asked by **Master Noor Hussain** regarding decreasing of agriculture land day by day due to large number of residential and commercial constructions, on behalf of **Agriculture Minister, Mr. Abdul Haq Khan, Hon'ble Minister for RDD** assured the House that Government will stop constructions on agriculture land and mechanism will be framed in this regard to stop further conversion of agriculture land in the Residential or Commercial. While intervening, **Shri. Basarat Ahmad Bukhari, Hon'ble Minister for Revenue** Stated that a circular has been issued by the Revenue Department regarding banning of conversion of agriculture

land into Commercial/ Residential. He also Stated the Chief Secretary will direct all DC's not to release salary of Patwaris, Naib Tehsildars, Tehsildars till a certificate to the effect that no conversion of agricultural land has taken place is obtained from them.

While replying to **Starred C.Q.No. 493** asked by **Shri. Yasir Reshi regarding rehabilitation of orchardists**, whose orchards were fully damaged in the recent devastating floods. **Mr. Abdul Rehman Veeri, Hon'ble Minister** assured the House that relief will be provided to the affected families of the area.

The replies of **Starred C.Q.Nos. 102, 194, 343, 527, 226, 171,613 & 334** and **Unstarred C.Q.Nos. 70, 16, 652, 582, 664, 130, 51 & 405** were laid on the table of the House.
