The Council met in the Council Hall, Srinagar at 11:00 Hrs

As soon as the **House assembled for today's business, Hon'ble Chairman, Haji. Anayat Ali** condemned the yesterdays Militant attack at Kud in which one lady died and another lady namely Ms. Ruby w/o Shri Ravi Kumar R/o Krishena Nagar, Jammu who is class IV employee of this Secretariat got seriously injured and is admitted in Army Hospital Udhampur. Government is directed to provide best health medical facilities to the injured.

Nabi Lone** stated that appointments under SRO-43 will be taken on fast trak basis and the process will be completed as soon as possible.

In response to **Starred C.Q.No. 480** asked by **S. Not satisfied with the reply **Members from NC** later staged a walk out.

In response to **Starred C.Q.No. 157** asked by **Sofi Yousuf, Hon'ble Member** regarding construction of Bridge from Goihard to Poru at Kokernag, **Hon'ble MOS for R&B** assured the House that it will be completed by Mar-2017.

Mr. Surinder Mohan Ambardar, Hon'ble Member requested the Government that 10 lakh ex-gratia be provided to the next of kin of Shikarawala who lost his life while rescuing a tourist at Fateh Kadal.
