Ali Mohammad Dar, Hon'ble Member** regarding utilization of funds for land compensation for construction of Power Grid Station at Village Noubugh, Chadoora. **Mr. Farooq Ahmad Andrabi, Minister of State for PDD** assured the House that he will personally look into it & get work started.
