(Brief Record Of Proceedings)

The Council met in the Council Hall, Srinagar at 11:00 Hrs

(Hon'ble Chairman Haji. Anayat Ali in the Chair)

11:00 Hrs

Shri. Ramesh Arora, Hon'ble Member raised an issue that proper waiting room may be provided to the Hon'ble Members in the Civil Secretariat as well as at Legislature Complex. On this **Syed. Naeem Akhter, Leader of the House** informed the House that there should be lobby for **Hon'ble** Members in the Council Secretariat.

Shri. Vibod Gupta, Hon'ble Member raised an issue regarding constitution of joint House Committee regarding Member amenities. On this **Syed. Naeem Akhter, Leader of the House** stated that House Committee constituted in the Lower House has already been disbanded.

Mr. G. N. Monga, Hon'ble Member raised an issue regarding change in Industrial Policy and demanded that that Government should come up with a statement in this regard.

Shri. Naresh Kumar Gupta, Hon'ble Member raised an issue regarding yesterdays road accident at Raginallah Batote in Doda in which 3 person died and 1 got injured and there is total shutdown in Doda Town in protest of police Lathi-charge and demanded that D.C and S.S.P Doda be transferred and demanded that Government should come up with a statement in this regard.

Mr. Javid Ahmad Mirchal, Hon'ble Member raised an issue that maximum people of my constituency move to pastures (bahaks) and some disease has broken out to the animals and requested that immediately a medical team be dispatched there.

On this Syed. Basharat Ahmad Bukhari, Hon'ble Minister for Revenue informed the House that government will send a team there and necessary steps will be taken in this regard.

Mr. Zaffar Iqbal Manhas, Hon'ble Member stated that everything is not reflected in the bulletin. On this the Chair informed the Member that the Bulletin is always brief, however he directed the information department and Media to reflect the issues raised by the Hon'ble Members in detail in the press .

Question Hour

Starred C.Q. Nos. 239, 283, 211, 108, 518, 266, Clubbed C.Q.No's (509, 567) & 597 were orally answered.

C. Q. NO. 239 asked by Shri. Sham Lal Bghat, Hon'ble Member raised an issue regarding Medical Colleges. On this **Shri. Bali Baghat, Hon'ble Minister for Health** replied the supplementaries raised by the Hon'ble Members.

C. Q. NO. 283 asked by **Shri. Surinder Kumar Choudhary, Hon'ble Member** regarding Municipal Committee. On this **Ms. Asea Naqash, MOS for Housing** stated that the concerned officers will be directed to prepare DPRS for left out works regarding lanes and drains at Nowshera.

C. Q. NO. 211 asked by **Shri. Ramesh Arora, Hon'ble Member** regarding simplifying procedure for Issuance of Certificate. On this **Syed. Basharat Ahmad Bukhari, Hon'ble Minister for Revenue** assured the House that the settlement of issuance of Certificate will be made easier and government is looking into it. A transfer policy will be formulated very soon.

C. Q. NO. 108 asked by **Shri. Jugal Kishore, Hon'ble Member** regarding opening of new Degree Colleges. On this **Syed. Naeem Akhter, Hon'ble Minister for Education** stated that infrastructure will be created in the existing colleges.

C. Q. NO. 518 asked by **Shri. Saif-Ud-Din Bhat, Hon'ble Member** regarding Doodhpathri. On this **Syed. Naeem Akhter, Hon'ble Minister for Education** stated that a survey was conducted for Gondola service at Doodhpathri which was not found technically feasible.

C. Q. NO. 266 asked by **Dr. Shehnaz Ganai** regarding Registration of Vehicles, not satisfied with the reply Chair **deferred** the Question.

Clubbed (C. Q. NO's. 509, 567) asked by **Shri. Yasir Reshi & Shri. Zaffar Iqbal Manhas Hon'ble Members** regarding Road Accidents, while intervening **Syed Basharat Ahmad Bukhari, Hon'ble Minister for Revenue, stated** that out dated vehicles including SRTC will be off routed very soon, there is a criteria that old vehicles has to pass manual test after 15 years. During driving the use of Mobiles is an offence.

C. Q. NO. 597 asked by **Shri. G. N. Monga, Hon'ble Member** regarding pending Court Cases, while intervening **Syed Basharat Ahmad Bukhari, Hon'ble Minister for Law** stated that process for creation of establishing of subordinate courts will be with the consultation of Hon'ble High Court and decision will be taken accordingly.

The replies of Starred C.Q. No's. 616, 319, 181, 349, 90 & 512 and Un-starred C.Q.No's. 377, 489, 402 & 544 were laid on the table of the House.

Mr. G. N. Monga, Hon'ble Member raised the issue of industrial policy again and was supported by other Members from opposition., on this the Chair directed Hon'ble Minister for PHE to take cognizance of the issue and directed the Government to come with a statement by tomorrow.
