Point of Information

Shri. Ramesh Arora, Hon'ble Member raised an issue regarding shortage of sugar for the last 2 months in Jammu and requested to take necessary steps in this regard.

Mr. Adbul Haq Khan, Hon'ble Minister for RDD informed the House that keeping in view month of Ramzan government supplies extra sugar to Kashmir province, however the sugar will be provided in Jammu as per the quota.

Shri. Ramesh Arora, Hon'ble Member again raised an issue regarding free Medicare facilities to Ruby w/o Ravi Kumar. On this

Mr. Adbul Haq Khan, Hon'ble Minister for RDD informed the House that he called up D.C Udampur personally and D.C Udampur visited M.H and assured that he will do whatever may possible.

Hon'ble Members from Opposition as well as from treasury benches raised an issue regarding un-parliamentary words used by Hon'ble Minister yesterday and requested the Chair to direct the concern Minister to apologize in the House.

On this the Chair directed the government that this is a serious issue and sought reply.

Mr. Adbul Haq Khan, Hon'ble Minister for Law regretted on behalf of the concerned Minister.

Starred C.Q. No's. 260, Clubbed C.Q. No's. (184 & 546), Clubbed C.Q. No's. (86, 584 & 626) & Clubbed C.Q. No's. (551 & 703) were orally answered.

C.Q.NO.260 asked by Dr. Shehnaz Ganai, Hon'ble Member regarding Women/Children Harassment. On behalf of Minister for Home, Mr. Adbul Haq Khan, Hon'ble Minister stated that all women police stations will be made functional as soon as possible. Dr. Shehnaz Ganai stated that figures regarding juveniles is not correct. While intervening Syed. Naeem Akhter Andrabi, leader of the House stated that government in its first cabinet meeting took some measures regarding women's welfare, which includes establishment of women police stations, out of which 4 are functional including Rajouri and Anantnag and rest will be made functional as soon as process is completed.

Not satisfied with the reply, Hon'ble Member staged a walk out.

On behalf of Minister for Science and Technology, Mr. Abdul Haq Khan, Hon'ble Minister informed the House that he has already directed the department to hold an enquiry how wrong information has been provided and action will be taken against the persons involved in it. LEGISLATIVE BUSINESS
*(BILLS FOR CONSIDERATION AND RETURN)

I) Mr. Haseeb A. Drabu, Hon'ble Minister for Finance moved that:-
"A Bill to provide for the withdrawal of certain sums from and out of the Consolidated Fund of the Jammu and Kashmir State for the services of the Financial year 2016-17 (L.A Bill No. 3 of 2016) as passed by the Jammu and Kashmir Legislative Assembly, be taken into consideration".
Mr. Abdul Haq Khan, Minister for Law seconded the Bill.
The Bill was considered clause by clause by Voice Vote. Clause 1 to 3 & schedule treated as parts of Bill.
Mr. Haseeb A. Drabu, Hon'ble Minister for Finance moved that the Bill be returned to Legislative Assembly.
The Bill was adopted & returned to Legislative Assembly.

Shri. Ashok Khajuria, Hon'ble Member raised an issue regarding dumping of garbage in Nagrota park at Ustad Mohalla.

Shri. Sham Lal Baghat, Hon'ble Member raised an issue regarding delaying of works under RGGVY schemes in Marmat & other areas, though tenders were floated.

Mr. Showkat Ahmad Ganai, Hon'ble Member requested that teachers who were working in Flai Aam trust be regularized.

Shri. Vikramaditya Singh, Hon'ble Member raised an issue for conducting awareness programs & constitution of rehabilitation & counseling centers.

Mr. Saif-Ud-din Bhat, Hon'ble Member regarding providing of dumping site for Budgam District & appointment sweepers at Panchayat.

Mr. Mohammad Khursheed Alam, Hon'ble Member raised an issue regarding construction of public convenience / sulabh at tourist places & wash rooms near religious places in Srinagar city.

Vice Chairman Directed that Public convenience be also created at Mugal Raod.

Mr. Yasir Reshi, Hon'ble Member raised an issue regarding appointment of 61 Asha workers by Block President.

Mr. Jugal Kishore Sharma, Hon'ble Member requested that I-Pads be provided to the Legislators and also TA of the Hon'ble members be paid in cash instead depositing in their bank accounts as was practice earlier.
