2. PAPERS TO BE LAID

3. CALLING ATTENTION

- i) Mr. Naresh Kumar Gupta, Hon'ble Member** to call the attention of the government, towards a matter of urgent public importance namely, the situation that has arisen due to vacant office of the State Chief Information Commissioner, with the result hundreds of cases are lying un-attended, thereby causing great inconveniences to the public at large and the steps taken by the Government in this behalf.
- ii) Mr. Showkat Hussain Ganai, Hon'ble Member** to call the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to bad condition of Pratabpora-Ziapora to Baripora road in District Shopian and steps taken by the Government in this regard.

- iii) **Mr. Vibod Gupta, Hon'ble Member** to call the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to non-availability of Sanskrit teachers in Rajouri District in particular and Jammu Division in general, due to which number of students of the language has diminished to almost nil and the language is near extinction and the steps underway to save this valuable language.
- iv) **Mr. Surinder Choudhary, Hon'ble Member** to call the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to delay in construction of road from Kahian to Handan via Sewbha in Tehsil Nowshera, District Rajouri despite availability of funds and the steps taken by the Government in this behalf.
