REGARDING : HAJ COMMITTEE

137. U/S(C. Q. No. 544) Shri Mohammad Muzzafer Parray : Will the Government be pleased to state :-

(a) whether it is a fact that State Haj Committee was constituted in the State of J&K in the year 2007-08 ;

(b) whether it is a fact that first elected Chairman of State Haj Committee had resigned from the post before his term expired in the year 2011 ;

(c) whether it is a fact that first Chairman elected has not drawn any pay or perks and has worked for the period without any remuneration or facility he was entitled to ;

(d) whether they are conscious to re-constitute the State Haj Committee strictly as provided in the Haj Committee Act, passed by the Parliament and give space to the NGO representatives connected with Islamic studies and guidance actively in the State of J&K ;

(e) whether it is a fact that criteria given in the Haj Act, for appointment of Executive Officer, Haj Committee is not adhered to and the officer in State Haj Committee is, allowed on the post uninterruptedly in violation of transfer policy of the State Government policy, the Government has widely propagated ;

(f) whether they are committed to post the Executive Officers of State Haj Committee by inviting applications from the State Officer as is done in the appointment of CEO (Chief Executive Officer) Central Haj Committee, Mumbai and officers holding degrees in Islamiyat Deeniyaat Law and Urdu are preferred for such assignment/ appointment by the Government ;

(g) whether it is a fact that Secretary, Haj and Auqaf Department along with Executive Officer, Haj Committee (J&K) and Haj Officer was deputed to Saudi Arabia for none of their job as a good number of Khadim-ul-Hujaj had already reported in the Haj Mission of India in Mekah for duties of Haj 2015 ;

(h) whether it is a fact that they (Haj Committee) had spent lacs of rupees on the visit of the above officers for nothing substantive done in Haj 2015 by these officers ; and

(i) if the reply in negative please state the reasons ?
