2. MESSAGE

SECRETARY to read the message regarding Bills assented to by the Hon'ble Governor.

3. CALLING ATTENTION

- i) **DR. SHEHNAZ GANAI, HON'BLE MEMBER** to call the attention of the government towards a matter of urgent public importance, namely, the situation that has arisen due to non-availability of Lawyers' Chambers and Library in District Court Complex Poonch.
- ii) **SMT. RANI GARGI BLOWRIA, HON'BLE MEMBER** to call the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to the encroachment of forest and State land by powerful persons, politicians and bureaucrats in State with the help of Revenue Officers/officials.
- iii) **MR. QAISER JAMSHEED LONE, HON'BLE MEMBER** to call the attention of the government towards a matter of urgent public importance namely, the situation that has arisen due to sudden presence of insects in Village Shumliyal, Lolab and has created havoc in general public.

4. PRIVATE MEMBERS' RESOLUTIONS

- (i) **DR. BASHIR AHMAD SHAH VEERI, HON'BLE MEMBER** to move:-
"This House resolves that due status be given to Urdu language, which is official language of the State and be introduced as compulsory subject in all State run and private institutions up to 10th class and for all government/judiciary services examinations, which include- PSC, SSRB, District Level Recruitment Exams, all levels of Judicial Services, Revenue, Police services and other departments".

- (ii) **MR. ZAFFAR IQBAL MANHAS, HON'BLE MEMBER** to move:-
“This House resolves that vehicle parking space availability be made mandatory before issuing vehicle registration certificate to the owner of the vehicle”.
- (iii) **MR. YASHPAL SHARMA, HON'BLE MEMBER** to move:-
“This House recommends to the Government of India that Railway Services be extended to the twin Districts of Poonch and Rajouri to provide better connectivity to the capital cities of Jammu and Srinagar”.

“This August House resolves that Mughal Road be made all weather road by way of construction of tunnel”.
