BRIEF RECORD OF PROCEEDINGS**

The Council met in the Council Hall, Srinagar at 11: 00 AM.

(Hon'ble Chairman Haji Anayat Ali in the chair)

11.00 Hrs

The House assembled for today's business Opposition Members from NC & Congress were demanding adjournment of business, to discuss the problems of daily- wage workers demanding their regularization and also latest killings in the State. On this, Hon'ble Chairman directed the Members to take their seats as a *clubbed Starred C.Q. No. viz 19, 71, 11, 183 & 143* on the same subject matter are listed today & a threadbare discussion can be held on it. The Motion of adjournment of House against the recent killings in the State moved by NC was disallowed by the Chair. The Members from BJP also demanded action against *Er. Rashid, MLA* for hosting a beef party at MLA's Hostel. On this, Hon'ble Chairman ruled, since the Member belongs to Lower House, discussion on this cannot be held in this House.

Syed Basharat Ahmad Bukhari, Hon'ble Minister for Law, Justice and Parliamentary affairs condemned the incident which took place in Lower House and said that in democracy every citizen have freedom to live as per constitution. Nobody can criticize any one and stated *that Hon'ble Deputy Chief Minister* has already condemned today's episode in Lower

House. *Shri Bali Bhagat Hon'ble Minister for Forest* also stated that yesterday's incident is highly condemnable & stressed for strengthening of Secular fabric, while intervening *Sh. Abdul Haq Khan, Hon'ble Minister for Rural Development* stated that whatever *Er. Rashid* has done is only to remain in news. The NC Members staged a walkout.

QUESTION HOUR

Starred C.Q. No's. 56, 209, 233, 67, 46, 101 and 62 were orally answered.

In response to *Starred C.Q. No. 233* asked by *Mr. Mohd. Khursheed Alam, Hon'ble MLC* regarding SAGY, *Mr. Abdul Haq Khan, Hon'ble Minister for Rural Development Department* assured that if there is any such kind of misappropriation of funds, an inquiry will be conducted.

The Members from Congress Party also staged walkout.

Hon'ble Members from NC returned and again started protest against the statement of **Finance Minister, Mr. Haseeb Drabu** regarding misuse of CDF funds by Legislators published in today's news paper and were demanding statement from **Finance Minister** and again staged walk out.
